3. Substitutions for absent colleagues.
4. Scheduled activities/tasks associated with the College's Quality Assurance systems.

5. Maintain up to date resources.
6. Development of new resources and population of the VLE.
7. Attend relevant staff development
8. Management and administration. This may include:
  - contributing to College administration or the administration of education and training programmes.
  - publicity and public relations.
  - participation in appropriate team and committee meetings and course management duties including the interviewing, induction, assessment and examination of students.
  - preparing statistical returns including retention rates, examination results, student progress placement and destination.
  - participation in student monitoring and reporting and course review and evaluation procedures.
  - participation in quality assurance and control procedures.
9. To provide information for the self-assessment and course review process in relation to functional skills.
10. To organise diagnostic assessments and initial assessments.
11. To update the electronic student profile.
12. To maintain records relating to the levels and achievements of students and set appropriate targets.
13. To carry out any other duties which may be required from time to time and which are commensurate with the post.

It is management policy that roles and responsibilities are reviewed on a regular basis leading to possible modifications where appropriate. Staff may be asked to undertake other duties as may be reasonably required commensurate with the post, at the initial place of work or at other locations from which the College operates.

The post is offered on the Southport Education Group contract for newly appointed tutors.
